3. The expenditure involved is debit to the Major Head "2230" Labour and Employment 01 Labour 01.113 Improvement in Working Condition of Child/Women Labour -02 - Child Labour Cell -02.03 - National Child Labour Projects - 02.03.31- Grants-in-aid for the year **2007-08(PLAN)**.
4. The grant-in-aid will be released in accordance with procedure laid down in the Ministry of Finance, Department of Economic Affairs Office Memorandum No. 10(48)-B/68 dated 25th November, 1969. The Section Officer (Cash Section)/ Drawing and Disbursing Officer, Ministry of Labour & Employment, New Delhi will draw the amount sanctioned vide para 1 above for **Rs. 52,69,500/- (Rs. Fifty Two Lakh Sixty Nine Thousand & Five Hundred Only)** and remit the same to the **District Magistrate & Chairman, National Child Labour Project Society, District Dakshin Dinajpur, West Bengal**, through crossed demand draft under intimation to Child Labour Section.
