4. The grant-in-aid will be released in accordance with procedure laid down in the Ministry of Finance, Department of Economic Affairs Office Memorandum No. 10(48)-B/68 dated 25th November, 1969. The Section Officer (Cash Section)/ Drawing and Disbursing Officer, Ministry of Labour & Employment, New Delhi will draw the amount sanctioned vide para 1 above for **Rs. 53,07,500/- (Rupees Fifty Three Lakh Seven Thousand & Five Hundred only)** and remit the same to **the District Magistrate & Chairman, Nadia Zilla Shishu Shramik Punarbasan Samity, District Nadia, West Bengal** through crossed demand draft under intimation to Child Labour Section.
