Madam,

I am directed to convey the Administrative Approval & Expenditure Sanction approval of the Competent Authority for implementation of the Centrally Sponsored Scheme 'Certification of Skills for Workers in the Informal Sector' in the State of Orissa. I am also directed to convey the Sanction of the President to release the first installment amounting to Rs.5,00,000/- (Rupees Five Lakh only), i.e. 50% of the total cost to the State Government of Orissa, for utilization of the funds by Directorate of Technical Education & Training, Govt. of Orissa for carrying out the under-mentioned activities.

(a) Training of Identified Assessors/ Trainer Assessors - (i.e., 50% of the Total cost of Rs.6.00 lakh)	Rs. 3.00 lakh
(b) Advertisement of Publicity - (i.e., 50% of the Total cost of Rs.2.30 lakh)	Rs .1.15 lakh
(c) Creating a Cell in the State - Office Furniture, Computers and office stationery (i.e., 50% of the Total cost of Rs.1.50 lakh)	Rs. 0.75 lakh
(d) Printing of Skills Competency Certificates (i.e., 50% of the Total Cost of Rs. 0.20 lakh)	Rs. 0.10 lakh

(2) The second installment of Rs. 5.00 lakh will be released after the State Government (i.e. Directorate of Technical Education & Training, Govt. of Orissa) furnishes a statement of Accounts, detailing the expenditure incurred on the various activities for which funds were released together with Utilization Certificate in form GFR 19(A).

The release of Central funds for the said activities is subject to the following conditions:

- The **Directorate of Technical Education & Training, Govt. of Orissa** shall ensure that the Grant is utilized for the purpose, for which, it is sanctioned.
- The **Directorate of Technical Education & Training, Govt. of Orissa** should maintain separate accounts for the funds released under the scheme and furnish a statement of accounts detailing the expenditure on the various activities for which funds are released along with UC in Form GFR 19(A).
- Funds so released should be utilized by Directorate of Technical Education & Training, Govt. of Orissa as early as possible (within current financial year i.e.2006-07). Any amount not spent by that time, should be surrendered to the Central Government.
- The Directorate of Technical Education & Training, Govt of Orissa would be authorized to conduct examinations for award of certificates. The authorization could be withdrawn on non-fulfillment of requirements of this Directorate General.
- The DGE&T, Ministry of Labour & Employment would help the Directorate of Technical Education & Training, Govt. of Orissa in the following:
 - (v) Defining competency levels
 - (vi) Laying down testing & certification procedure
 - (vii) Framing guidelines for charging fees from workers for Testing and Certification.
 - (viii) Identifying Training Centers for Training of Assessors.
- The Directorate of Technical Education & Training, Govt.of Orissa should ensure that no permanent asset is generated out of the aforesaid grant.

3. The expenditure involved for the said work will be debitable to the Major Head,
