Subject: Construction of building for existing ITI Gauripur in the State of Assam under the Centrally Sponsored Scheme of "Establishment of new Industrial Training Institutes (ITI s) in the North-Eastern States and Sikkim".

Sir,

In continuation to this Ministry's letter of even No. dated 21.11.2003, I am directed to convey the sanction of the President for the release of third installment amounting to **Rs. 15,85,000 (Rupees Fifteen Lakhs Eighty Five Thousand only)** to the State Government of ASSAM for ITI Gauripur for the construction of the Workshops for the approved trades under the CSS, Existing trades and Administrative Block at ITI Gauripur as per the proposal submitted by the State Directorate vide letter No. DET(E)PM-35/2001/46132 dated 23.05.2002 for the aforementioned scheme.

2. The release of Central fund of Rs 15,85,000/- to the State Government of ASSAM in respect of the said scheme is subject to the following conditions:

- (i) The building for the ITI should be constructed in accordance with the NCVT approved space norms.
- (ii) The grant shall be utilized only for the purpose for which it has been sanctioned and no portion of it shall be spent on any other item.
- (iii) The amount sanctioned should be utilized within a period of one year from the date of issue of the sanction and any amount not spent by that time should be surrendered to the Central Government.

(iv) The Utilisation Certificate in Form GFR 19-A indicating expenditure under the scheme should be furnished to the Directorate General in Duplicate within 12 months.

(v) The work shall be awarded after open competition / bidding / tendering through PWD / CPWD.

3. The sanction relates to Plan Expenditure and is in accordance with the pattern of assistance approved by the Planning Commission and Ministry of Finance.
