Subject: Strengthening of existing ITI at Takyelpat in the State of MANIPUR under the Centrally Sponsored Scheme of 'Establishment of new Industrial Training Institutes (ITI s) in the North Eastern States and Sikkim'.

Sir,

In continuation to this Ministry's letter of even No. dated 29.06.2005, I am directed to convey the sanction of the President for the release of third installment amounting to **Rs. 5,60,000 (Rupees Five Lakhs Sixty Thousand only)** to the State Government of MANIPUR for the construction of Workshops for existing ITI Takyelpat as per the proposal submitted by the State Directorate vide letter No. 3/155/99-Trg. dated 13.11.2003 for the aforementioned scheme.

2. The release of Central fund of **Rs. 5,60,000/-** to the State Government of MANIPUR in respect of the said scheme is subject to the following conditions:

- (i) The ITI should be constructed in accordance with the NCVT approved space norms.
- (ii) The grant shall be utilized only for the purpose for which it has been sanctioned and no portion of it shall be spent on any other item.
- (iii) The amount sanctioned should be utilized within a period of one year from the date of issue of the sanction and any amount not spent by that time should be surrendered to the Central Government.
- (iv) The Utilisation Certificate in Form GFR 19-A indicating expenditure under the scheme should be furnished to the Directorate General in Duplicate within 12 months.
- (v) The work shall be awarded after open competition / bidding / tendering through PWD/ Technical & Promotional Cell, Manipur.

3. The sanction relates to Plan Expenditure and is in accordance with the pattern of assistance approved by the Planning Commission and Ministry of Finance.

4. The expenditure is debit to the Major Head "3601" during FY 2006-2007-
