Subject: Construction of new ITI Baghmara in the State of MEGHALAYA under the Centrally Sponsored Scheme (CSS) of 'Establishment of new Industrial Training Institutes (ITI s) in the North-Eastern States and Sikkim'.

Sir,

In continuation to this Ministry's letter of even No. dated 02.11.2004, I am directed to convey sanction of the President for **release of second installment of Rs. 37,50,000/- (Rs. Thirty Seven Lakhs Fifty Thousand only)** to the State Government of Meghalaya for the construction work in new ITI Baghmara under the CSS as per the proposal submitted by the State Directorate vide letter No. DET(M)PL-2000/Pt/218789 dated 9.07.2003 for the aforementioned scheme.

2. The release of Central fund of **Rs. 37,50,000/-** to the State Government of Meghalaya in respect of the said scheme is subject to the following conditions:
- The ITI should be constructed in accordance with the NCVT approved space norms.
 - The grant shall be utilized only for the purpose for which it has been sanctioned and no portion of it shall be spent on any other item.
 - The amount sanctioned should be utilized within a period of one year from the date of issue of the sanction and any amount not spent by that time should be surrendered to the Central Government.
 - The Utilisation Certificate in Form GFR 19-A indicating expenditure under the scheme should be furnished to the Directorate General in Duplicate within 12 months.
 - The work shall be awarded after open competition / bidding / tendering through PWD.
3. The sanction relates to Plan Expenditure and is in accordance with the pattern of assistance approved by the Planning Commission and Ministry of Finance.
4. The expenditure is debitable to the Major Head "3601" during FY 2006-2007-
