Subject: Reimbursement of Staff Salary of Rs 39,91,556/- for 3 Existing ITI (Kohima Women ITI, Dimapur and Mon) and 4 New ITI (Phek, Wokha Mokokchung and Tuensang) in the State of Nagaland under the Centrally Sponsored Scheme of "Establishment of Industrial Training Institutes (ITI s) in the North Eastern States and Sikkim".

Sir,

I am directed to convey sanction of the President for release of **Rs.39,91,556/- (Rupees Thirty nine lac ninety one thousand five hundred and fifty six only)** as Grant-in aid towards recurring expenditure for Staff Salary for 3 Existing ITI (Kohima Women ITI, Dimapur and Mon) and 4 New ITI (Phek, Wokha Mokokchung and Tuensang) in the State of Nagaland for a period of six months from 1-12-2005 to 31-05-06 under the Centrally Sponsored scheme "Establishment of Industrial Training Institutes (ITI s) in North-Eastern States and Sikkim" during Financial Year 2006-2007.

1. The release of Central fund of **Rs.39,91,556/- (Rupees Thirty nine lac ninety one thousand five hundred and fifty six only)** in respect of the said scheme is subject to the following conditions :
- (i) The reimbursement of Salary should be strictly in conformity with the approved posts as conveyed to you in respect to your institute vide letter No. DGET-2(4)-2000-03-CPIU/NES-Nagaland dated 10th July 2003.
- (ii) The grant shall be utilized only for the purpose for which it has been sanctioned and no portion of it shall be spent on any other item.
- (iii) The amount sanctioned should be utilized within a period of one year from the date of issue of the sanction and any amount not spent by that time should be surrendered to the Central Government.
- (iv) The Utilisation Certificate in Form GFR 19-A indicating component-wise expenditure under the scheme should be furnished to the Directorate General in Duplicate for claiming further releases on recurring expenditure.
