Subject: Sanction for **Civil Works** in **ITI Rourkela, Orissa** under the Centrally Sponsored Scheme "Upgradation of ITIs into Centres of Excellence" - regarding.

Sir,

I am directed to convey the sanction of the President of India to incur an expenditure not exceeding **Rs. 30.00 Lakhs (Rupees Thirty Lakhs only)** for the construction/renovation of existing building at **ITI Rourkela, Orissa** for conducting courses in the sector "**Production & Manufacturing**" under the Centrally Sponsored Scheme "Upgradation of ITIs into Centres of Excellence" during the Financial Year 2006-2007.

2. I am also directed to convey the sanction of the President of India for the release of 25% of the aforesaid amount as 1st installment amounting to **Rs. 7.50 Lakhs (Rupees Seven Lakhs and Fifty Thousand only)** to the State Government of **Orissa** for the construction / renovation of existing building at **ITI Rourkela** as per the approved norms of National Council for Vocational Training (NCVT)/ DGE&T. The proposal related to civil works of afore-mentioned ITI was submitted by State Director, Directorate of Technical Education & Training, Orissa.

3. The release of **Central fund of Rs. 7.50 Lakhs** in respect of the afore-said scheme is subject to the following conditions:

- a) The ITI should be renovated / constructed in accordance with the NCVT approved space norms and estimates prepared by PWD/State approved agency.
- b) The grant shall be utilized keeping in view the guidelines of the scheme / MoU and only for the purpose for which it has been sanctioned and no portion of it shall be spent on any other item.
- c) The amount sanctioned should be utilized within a period of one year from the date of issue of the sanction and any amount not spent by that time should be surrendered to the Central Government. Any expenditure incurred over & above the sanctioned amount shall be borne by the State Government from their own funds.
- d) IMC clearance must be obtained before initiating bidding/tendering for civil works.
- e) The work shall be awarded after open competition/bidding/tendering through PWD.
- f) The bid documents, bids, bids evaluation reports and letter of awards should be retained by the State Directorate for post award review by DGE&T.
- g) The Utilization Certificate in Form GFR 19 -A indicating component-wise expenditure under the scheme should be furnished to the Directorate General of Employment & Training in duplicate
- h) The second installment of 50% of Central Share of sanctioned amount shall be released based on the documentary evidence, photographs indicating progress of work / sample survey by DGE&T.

4. The sanction relates to Plan Expenditure and is in accordance with the pattern of assistance approved by the Planning Commission and Ministry of Finance.
5. The expenditure is debit to the following Head of Account :-
