Subject:: Upgradation of ITIs in the State of Himachal Pradesh under the Centrally Sponsored Scheme of "Upgradation of ITIs into Centres of Excellence"- Equipment procurement for BBT/Advanced Module Training in existing ITIs : regarding .

Sir,

(1) It is in super-session of this Directorate General letter of even no dated 22/6/2007

(2) This has reference to the letter of even No. dated 8<sup>th</sup> Feb., 2006 and(1) DGET-35(4)(87)/Pur/HP/Rampur/2005-PCT, (2) DGET- 35(4)(88)/Pur/HP/Solan/2005-PCT dt. 8.2.2006 wherein sanction of the President was accorded for an amount of Rs. 164.93 lakhs and 16.50 lakh was released as 10 % towards the 1<sup>st</sup> installment of Central share for procurement of Equipment for the three ITI of Himachal Pradesh under the scheme "Upgradation of ITIs into Centres of Excellence" under BBT/ Advanced training during the Financial Year 2005-2006 .

(3) I am now directed to release a further amount of Rs 71.89 lakhs (Rupees seven one lakhs eighty nine thousand only) equivalent to 70% of the central funds towards 2<sup>nd</sup> installment to the State Government of Himachal Pradesh for the purchase of equipment for BBT/ Advanced modules for the above ITIs as per the details given below:

3. The release of Central fund of Rs. 71.89 lakhs (Rupees seventy one lakh and eighty nine only) in respect of the said scheme is subject to the following conditions:

- (i) The equipment purchased should be strictly in accordance with the standard list of tools and equipment, as prescribed by NCVT for the particular trade as per State Purchase procedure/DGS&D / State Rate Contract.

- (ii) The grant shall be utilized keeping in view the guidelines of the Scheme/MoU and only for the purpose for which it has been sanctioned and no portion of it shall be spent on any other item.
- (iii) The amount sanctioned should be utilized within a period of one year from the date of issue of the sanction and any amount not spent by that time should be surrendered to the Central Government.
- (iv) The Utilisation Certificate in Form GFR 19-A indicating component-wise expenditure under the scheme should be furnished to the Directorate General in Duplicate.
- (v) After making purchases, bid documents, bids, bid evaluation reports and letter of award should be retained by the State Directorate for post-award review by DGE&T.
- (vi) IMC clearance should be obtained before procurement of equipment.
5. The sanction relates to Plan Expenditure and is in accordance with the pattern of assistance approved by the Planning Commission and Ministry of Finance.
6. The expenditure is debitible to the following Head of Account:-
