**Subject:** Upgradation of Government ITI s in the State of MIZORAM under the Centrally Sponsored Scheme of "Establishment of Industrial Training Institutes (ITI s) in the North Eastern States, Sikkim and Jammu & Kashmir"- Release of Final Installment for equipment procurement.

Sir,

This is in continuation of various sanctions issued earlier and the corresponding releases made as Grant-in aid, for New & Existing ITIs in the State of MIZORAM under the scheme "Establishment of Industrial Training Institutes (ITI s) in North-Eastern States, Sikkim and Jammu & Kashmir."

I am now directed to convey the sanction of the President for release of the **FINAL** installment of Rs. 27,32,568/- (Rupees Twenty Seven Lakh Thirty Two Thousand Five Hundred and Sixty Eight only), to the State Government of Mizoram as tabulated below :-

2. The release of Central fund of Rs. 27,32,568/- (Rupees Twenty Seven Lakh Thirty Two Thousand Five Hundred and Sixty Eight only) in respect of the said scheme is subject to the following conditions :

(i) The equipment purchased should be strictly in accordance with the standard list of tools and equipment, as prescribed by NCVT for the particular trade or as per the list prescribed under "Project 150" of CSTARI, Calcutta for Short Term Courses under the approved scheme.

- (ii) **The grant shall be utilized only for the purpose for which it has been sanctioned and no portion of it shall be spent on any other item.**
  - (iii) The amount sanctioned should be utilized within a period of one year from the date of issue of the sanction and any amount not spent by that time should be surrendered to the Central Government.
  - (iv) The Utilisation Certificate in Form GFR 19-A indicating component-wise expenditure under the scheme should be furnished to the Directorate General in Duplicate.
  - (v) After making purchases, bid documents, bids, bid evaluation reports and letter of award should be retained by the State Directorate for post-award review by DGE&T (CPIU).
3. The sanction relates to Plan Expenditure and is in accordance with the pattern of assistance approved by the Planning Commission and Ministry of Finance.
  4. **The expenditure is debitable to Major Head "3601" – Grants-in-Aid to State Governments and under Minor Head 04.321.03.02.31 – Establishment of New ITIs in North Eastern States and Sikkim and will be met out of the budget grant of FY 2007-2008.**

This issues in exercise of the delegated powers in consultation with the Finance-I Branch, Ministry of Labour vide their Dy. No. 187 dated 11.09.2007.


