Subject: Sanction for civil works in 5 ITIs in the State of Andhra Pradesh under the Centrally Sponsored Scheme of "Upgradation of training infrastructure in 100 Govt. ITIs".

Sir,

This sanction is in continuation to this ministry's letter of even No. dated 31.01.2006, 10.03.2006 and 28.02.2007, wherein sanction was accorded for a total amount of Rs.148.90 lakhs in respect of 5 ITIs as central share, which is 75% of the cost for the construction work / renovation work in the ITIs covered under the Centrally Sponsored Scheme (CSS) of 'Upgradation of training infrastructure in 100 Govt. ITIs', releasing total central funds of Rs. 37.22 lakhs as first installment to the State Government of Andhra Pradesh. The remaining 25% of the total cost of construction will be borne by the State Govt. as per MOU signed between the Central & the State Government.

I am now directed to convey the sanction of the President of India for the release of second installment amounting to **Rs. 99.40 lakh (Rupees Ninety Nine Lakh and Forty Thousand only)** against the above sanctioned amount to the State Government of Andhra Pradesh for the construction work in the 5 ITIs, as per details tabulated below. The proposal related to civil works in these ITIs was submitted by the Commissioner, Employment and Training, Andhra Pradesh vide their letter No. B1/8712(CoE)/04(Funds) dated 28.06.2006 and No.B1/871(CoE)/04(Funds) dated 06.10.2006.

2. The release of Central fund of **Rs. 99.40 lakhs** to the State Government of ANDHRA PRADESH in respect of the said scheme is subject to the following conditions:

- The ITIs should be renovated or constructed in accordance with the NCVT approved space norms and estimates prepared by PWD or State approved agency.
- The grant shall be utilized keeping in view the guidelines of the Scheme/ MoU and only for the purpose for which it has been sanctioned and no portion of it shall be spent on any other item.

- (iii) The grant should be utilized within a period of one year from the date of issue of the sanction and any amount not spent by that time should be surrendered to the Central Government.
- (iv) The Utilisation Certificate in Form GFR 19-A in respect of individual ITI indicating expenditure under the scheme should be furnished to the DGE&T in Duplicate.
3. The sanction relates to Plan Expenditure and is in accordance with the pattern of assistance approved by the Planning Commission and Ministry of Finance.
4. The expenditure is debit to the Major Head "3601" during FY 2007-2008
