Subject: Sanction for **Civil Works** in **ITI Dighaghat, Bihar** under the Centrally Sponsored Scheme "Up-grading Training infrastructure in 100 Govt. ITI's" - regarding.

Sir,

I am directed to convey the sanction of the President of India to incur an expenditure not exceeding **Rs. 30.00 Lakhs (Rupees Thirty Lakhs only)** for the construction/renovation of existing building at **ITI Dighaghat, Bihar** for conducting courses in the sector "**Production & Manufacturing**" under the Centrally Sponsored Scheme "Up-grading Training infrastructure in 100 Govt. ITI's" during the Financial Year 2007-2008.

2. I am also directed to convey the sanction of the President of India for the release of 25% of the aforesaid amount as 1<sup>st</sup> installment amounting to **Rs. 7.50 Lakhs (Rupees Seven Lakhs and Fifty Thousand only)** to the State Government of **Bihar** for the construction / renovation of existing building at **ITI Dighaghat** as per the approved norms of National Council for Vocational Training (NCVT)/ DGE&T. The proposal related to civil works of afore-mentioned ITI was submitted by State Director, Employment & Training, Bihar.

3. The release of **Central fund of Rs. 7.50 Lakhs** in respect of the afore-said scheme is subject to the following conditions:

- The ITI should be renovated / constructed in accordance with the NCVT approved space norms and estimates prepared by PWD/State approved agency.
- The grant shall be utilized keeping in view the guidelines of the scheme / MoU and only for the purpose for which it has been sanctioned and no portion of it shall be spent on any other item.
- The amount sanctioned should be utilized within a period of one year from the date of issue of the sanction and any amount not spent by that time should be surrendered to the Central Government.
- IMC clearance must be obtained before initiating bidding/tendering for civil works.
- The work shall be awarded after open competition/bidding/tendering through PWD.
- The bid documents, bids, bids evaluation reports and letter of awards should be retained by the State Directorate for post award review by DGE&T.
- The Utilization Certificate in Form GFR 19 - A indicating component-wise expenditure under the scheme should be furnished to the Directorate General of Employment & Training in duplicate
- The second installment of 50% of Central Share of sanctioned amount shall be released based on the documentary evidence, photographs indicating progress of work / sample survey by DGE&T.
