Madam,

The undersigned is directed to refer to above mentioned administrative approvals in which 50% of advance subsidy, as 1<sup>st</sup> instalment, was released to the Andhra Pradesh Government for the construction of houses by beedi workers in various districts in Andhra Pradesh and on the basis of Report received from the Commissioner of Labour, Govt. of Andhra Pradesh, Hyderabad vide its letter No. 02/11833/2005 dated 27.06.2008, I am to convey the sanction of the President of India for the release of 2<sup>nd</sup> instalment of subsidy, on reaching the construction at Roof Level or above, consolidating to **Rs. 3,85,20,000/-** (Rupees Three Crore Eighty Five Lakh And Twenty Thousand Only) for another **1,926 houses** sanctioned in various districts in Andhra Pradesh as per details given as under:
