Sub: Administrative approval for construction of 1008 houses by the beedi workers in Vellore Districts in Tamilnadu & release of 50% subsidy amounting Rs. 201.60 Lakh (out of a total subsidy of Rs. 403.20 Lakh) under the Revised Integrated Housing Scheme, 2005 as amended vide letter dated 02.02.07 - Release of 2<sup>nd</sup> instalment regarding.

Sir,

With reference to Commissioner of Labour's letter No. M4/68305/05 dated 05.07.2008 and in continuation to this Ministry's letter of even number dated 06-02-2007, I am directed to convey the sanction of the President for the release of 2<sup>nd</sup> instalment of central subsidy of Rs. 201.60 Lakh in respect of 1,008 houses in Vellore districts which are reported to reach roof level and above out of total subsidy of Rs. 403.20 Lakhs to the Government of Tamil Nadu. Out of eligible subsidy of Rs. 403.20 Lakhs, the Central subsidy of Rs. 201.60 Lakhs was released earlier during 2006-2007.

2. The approval is subject to the condition that the amount of subsidy would be released to the Commissioner of Labour, State Government of Tamilnadu which, in turn, would be released to the District Collectors Vellore Districts Tamilnadu by the State Government, as per provisions of RIHS, 2005, as amended vide letter dated 02.02.07. The expenditure would be debitible to Major Head -2230 01.109.Beedi Workers Welfare Fund 01.109.01 - Housing 01.109.06 - Revised Integrated Housing Scheme - 2005 06.00.33 - Subsidies from the budget grants during the financial year 2008-2009.

3. This issues with the approval of Director General (Labour & Welfare) under powers delegated to him in Para No. 3 (ii) under the Revised Integrated Housing Scheme, 2007 dated 27.04.2007.
